Security— Again a Major Focus Of This Year's Training Workshop

At the 2013 Training Workshops we discussed and demonstrated our plans for a more secure version of our free client software. We have since completed the conversion of more than 235 local governments to the encrypted version. Our staff began last June and had all converted but a handful by December, as was the goal. Several had hardware or I.T. resource issues that delayed our request to upgrade them by the end of 2014.

The main security enhancement:

- All occurrences of social security numbers, user ids and passwords are encrypted
- The url to the secure website is also encrypted, along with the "ncc/ncm" username and smart password

This upgrade included several additional security features.

- Transmit password must be updated every 76 days as it expires and is locked if not updated after 90 days, requiring the Clearinghouse to unlock
 - Viewing online and printing of social security numbers is set for each user and has three options:
 - I. All nine digits
 - 2. Last four digits
 - 3. No digits

Some other security features of the client software implemented over past few years:

- Export Excel file option requires user to have full nine digit access in order to create file with full SSN
- When setoff.txt file is downloaded and imported into the software, the file is deleted. The only occur-

rence of SSNs is in the encrypted database

The current number of users on the encrypted client software:

- Counties: 61Agencies: 16
- Municipalities: 173

Total: 250 61% of all participants use our software!

Other Security Features implemented in 2014 for all participants:

- All Excel files provided after a setoff only have the last four of SSN
- Only the match.dat (ASCII file used for I.T./3rd parties) currently has the entire nine digits. This will change in 2015 to only those that specifically request it

Already Participating—So Why Attend?

There must be a good reason that over 400 people have attended workshops EACH of the last five years.

There will be updates from staff with the N.C. Association of County Commissioners, League of Municipalities and Department of Revenue. Five Star Computing, the vendor for the Clearinghouse will also provide training and explain the latest upgrades on the client software.

If your local government is already participating there is probably no reason to attend the 10:30—11:30 morning session as that mostly covers the eligible participants and the required one-time paperwork/ agreements. But feel free to

attend and bring others if interested in seeing what we discuss. This session is entirely optional except for new prospective participants.

We highly advise that ALL local governments attempt to have at least one person attend the 1:00—3:30 afternoon session. There is always new information at that session.

The past five years have focused a great deal on our software and this year is no different.

Over the years we have had many local governments who attend each year to hear about recent changes to legislation and processes. In addition, both recent and future changes are discussed and ample time given in case vendors and/or I.T. changes are required.

We encourage counties and municipalities with large numbers of debts and/or multiple departments to bring I.T. staff. Third-party vendors are welcome but need to be accompanied by local government staff.

More Secure Methods For Excel ONLY Participants

While an Excel file may be the simplest method for a local government to submit an entire file of debtors, there are concerns. Excel is an easy way for anyone who can access the file to open and view SSNs and names.

There are three options for those local governments currently submitting Excel files.*

 Convert to our client software which has encryption and additional security features like masking SSNs by user

- Allow us to do your data entry (if only 150 debts or so and minimal additions/edits monthly). A great option for municipalities, housing authorities and most agencies.
- 3. Stay with Excel, but send with an encrypted password (contact us to provide your password). Not as secure as options I and 2 above, but better than not encrypting with a password.
- * does not refer to users of client software who import Excel files into the software.

In the near future, we will begin requiring an encrypted smart password for the Excel imports into our client software.

So if you are currently using Excel and would like to upgrade to our software call us or go ahead and complete the required online request form.

If interested in us doing the data entry, please call or email us.

The two safest alternatives to securing Excel data: 1) switch to our client software; or 2) let us do your data entry and eliminate the need to store Social Security Numbers

Can You Use Our Software If You Have Vendors/3rd Parties?

We have more than twenty local governments that use our software and receive ASCII and/or Excel files from another provider. There are at least four third-party vendors submitting files to their own secure folders. We transfer the files to the local govt.'s folders then connect via remote software to the local government and do the imports for them.

There are also varying methods of files that can be imported:

- An entire replacement file for a department/account code
- 2. (ADDS Only) Add the entire file to existing debts
- (ADD and ADJUST-MENTS) Add any new debts while also updating any existing debts (uses SSN and Unique Key)
- 4. (ADJUSTMENTS ONLY)
 Update existing debts and replace with new balance

The best method is NOT to do an entire replacement. That wipes out history and loses the priority, The other options do retain history and priority. See if your vendor/3rd party can provide just new debts and updates to existing debts.

We don't need 3rd parties to send us debts we have setoff as we have those balances. The preference is just new debts and those debts they collect directly.

Surplus Excel Files—Very Important But Often Neglected

When the Clearinghouse processes a setoff file from the Department of Revenue and Education Lottery, we identify if we received more funds for any debtor than they owe at the time. This can happen for various reasons, probably no fault of the local government or the Clearinghouse. Often, just a timing issue or the debtor may have filed multiple tax refunds or had a refund and lottery winning, or even multiple lottery winnings.

When this occurs the Clearing-house provides an Excel file (surplus.xlsx) of these surplus debtors/debts, if a refund must be processed.:

- I. SSN (last four digits)
- 2. Name
- Address from Dept. of Revenue
- Surplus Amount (as best determined by Clearinghouse)

- Fee (usually \$15 but often \$0 if already fee taken in calendar year)
- 6. Department

If using our software, do TRANSMIT-IMPORT FROM CLEARINGHOUSE-SELECTIVE and choose the surplus.xlsx.

ASCII/Excel Users can simply download surplus.xlsx with the others in the secure folder.

Announcements, Reminders, Updates and Tips:

Latest Version—2014.03a (March 2014)

In June the Clearinghouse made available a self-extracting file that installs the latest version of the software for either Windows 7 or Windows XP. The main reasons for the upgrade:

- Code signature (signifies we are a trusted software developer and our code has not been altered) upgraded from I year (expiring in July 2014) to an additional two more years (expires in June 2016). Allows our software, when executed, to pass through most Virus Protection
 - Let us know if you encounter a warning message when executing the NCDebtsetoff.exe software application

In addition, another file was provided that is required to increase the level of file transfer security:

• DMZAPI Win 80.exe upgraded to the latest version, 8.0.0. When a Transmit-Export or Import is executed this Application Program Interface (API) sends the file encrypted to the secure

Contact us if you do not have version 2014.03a. If unsure, choose this option: verify

Reminders

- Delete Debtor • Be patient, do not click this button: Wait until the last setoff in mid-December and run the Year-end cleanup options to remove debtors.
- If choose this option you could be removing someone that has recently been setoff or will be setoff before we can remove their debt at the Department of Revenue and Education Lottery
- If we receive funds and attempt to apply the setoff against your debtors/debts, it will appear on the Error Report and show only the Unique ID it is looking for. We are depositing the funds in your account but can't apply to a debtor since the debtor has been removed. A sample of the Error Report when two debts were setoff for a debtor and the debtor and/or debts have been removed:

Updates

Software issues we have on our list:

- Excel File Export Ensure the Import/Export option matches the setoff.txt file and setoff report information - estimate is September 30, 2014
- When editing a debt, if changing Compliance Date, the Expiration Date changes to three years from Compliance, overriding the Account Code Configuration setting
- When adding or editing debt, have cursor appear on the debt amount
- Online Help and PDF (to be current with the above software changes) estimate Sept. 8, 2014
